How To File an Answer to a Foreclosure Complaint

Attached is a blank Answer form

You have 28 days to file an Answer

- File the original and one copy with the Clerk of Court
- Copies of your Answer must be mailed to the Plaintiff's attorney and to all other Defendants

If you do not file an Answer, the other side will win and get a foreclosure

The court will send you a notice of any hearings or court dates

It is important that you go to all hearings or court dates

If you receive other court papers, papers from the Plaintiff, or have other questions, you should contact an attorney

If you believe you have a claim against the lender because of your mortgage, you should contact an attorney
